

SCRAM Continuous Alcohol Monitoring™ (SCRAM CAM™) continues to be validated in court hearings across the country. To date, a SCRAM Systems expert witness has participated in 95 evidentiary-level hearings in 24 states, with 33 of the hearings resulting in a Daubert, Frye, or hybrid ruling. As part of the 95, three State Supreme and Appellate Court rulings have been made in favor of SCRAM CAM and subsequent monitoring results.

Since 2003, SCRAM Systems has been working with courts and ancillary agencies to provide comprehensive SCRAM CAM testimony, which has included the creation of over 2,000 formal court reports used to detail the monitoring results of offenders who denied a SCRAM CAM violation (either alcohol consumption, equipment tampering, or a combination). In the majority of the cases, offenders confronted by the court armed with a comprehensive SCRAM CAM reporting package admitted to the violation prior to the scheduled hearing

### What Is Daubert?

Written by the U.S. Supreme Court in 1993, Daubert, or Daubert v. Merrill Dow Pharmaceuticals, is a standard for courts to use to determine the admissibility of expert testimony. The intent is to ensure that testimony based on “junk science” not be admitted as evidence, as well as to ensure that new, cutting-edge scientific information, which meets a set of standards established in Daubert, is allowed to be considered by a court, even though it may be relatively new.

### What Is Frye?

Previous to Daubert, the standard for admissibility, Frye V. United States, applied the standard that scientific conclusions must be “generally accepted” within the expert community. This limited the admissibility of new scientific conclusions that might not yet be generally accepted. The Frye standard is still used in some jurisdictions, and yet others will use a hybrid standard that blends Frye and Daubert.
